- ❖ BUSINESS & CONTRACTOR FEE(S) ARE TO BE RENEWED ANNUALLY:
  - ➤ BUSINESS LICENSE FEE \$200.00
  - ➤ GENERAL CONTRACTORS \$200.00
  - ➤ ELECTRICAL CONTRACTORS \$200.00
  - ➤ SUB-CONTRACTORS \$100.00
