PRESENTATION OF PETITIONS:

Dan Spencer on Burnham Prairie Nature Preserve

Burnham Prairie is an approximately 80-acre natural preserve owned by the Forest Preserve District of Cook County. The site contains ridges or dunes of low elevation separated by shallow ponds, poorly drained lakebed, or swales intermittently or permanently inundated with groundwater. The site is home to 270 plant species, including two threatened plant species and one that is endangered; six endangered bird species; and a rare mammal, the Franklin's ground squirrel. The diversity is threatened by the absence of fire, and by contamination and modifications to the natural hydrology that have allowed non-native plant species to dominate, thus compromising the survival of native plants and animals.

The proposed project would re-route nutrient-polluted water away from the site and restore wetlands and associated habitats by planting high-quality native plants, removing invasive species and excess sediment, reintroducing fire management, and incorporating water storage outside of the natural area.

These activities will restore marsh, prairie, and savanna habitat that was historically present. Woodlands consisting of invasive woody species will be cleared with subsequent fire management to allow native seed banks of rare plant species to germinate. Restoring the remnant habitat will greatly benefit migratory and wetland species of birds, especially the shore birds and waterfowl that frequent the Calumet greenways, by providing forage, shelter, and breeding habitat.
