**BUD'S AMBULANCE AGREEMENT  
APPROVAL RESOLUTION**

**NUMBER: 2015 - R - 009**

**A RESOLUTION APPROVING AND AUTHORIZING THE EXECUTION OF AN AGREEMENT BETWEEN THE VILLAGE OF BURNHAM, COOK COUNTY, ILLINOIS, AN ILLINOIS MUNICIPAL CORPORATION, AND DALEY'S MEDICAL TRANSPORTATION, INC., d/b/a BUD'S AMBULANCE SERVICE, AN ILLINOIS CORPORATION, FOR PARAMEDIC AMBULANCE SERVICES.**

**WHEREAS**, the Village of Burnham, Cook County, Illinois has elected by referendum on March 11, 1980 to become a home rule unit, and accordingly, pursuant to the provisions of the Constitution of the State of Illinois of 1970, particularly Article VII Sec. 6(a) thereof, the Village is a home rule unit; and

**WHEREAS**, pursuant to the powers of a home rule unit set forth in Article VII, Section 6(a) of the Constitution of the State of Illinois of 1970, the Village may exercise any power and perform any function pertaining to its government and affairs including, but not limited to the power to regulate for the protection of the public health, safety, morals and welfare; to license; to tax; and to incur debt; and

**WHEREAS**, the Corporate Authorities of the Village desire to continue to provide emergency medical services for the residents of the Village;

**WHEREAS**, the Corporate Authorities of the Village are desirous of contracting with DALEY'S MEDICAL TRANSPORTATION, INC., d/b/a BUD'S AMBULANCE, an Illinois Corporation, (hereinafter referred to as BUD'S AMBULANCE), to provide such services;

**WHEREAS**, the Village and BUD'S AMBULANCE have negotiated the terms, provisions and conditions under which BUD'S AMBULANCE will provide for advanced life support / paramedic services for the Village and under which the Village will pay for such services in a written agreement entitled "AGREEMENT BETWEEN THE VILLAGE OF BURNHAM, COOK COUNTY, ILLINOIS, AN ILLINOIS MUNICIPAL CORPORATION, AND DALEY'S MEDICAL TRANSPORTATION, INC., d/b/a BUD'S AMBULANCE SERVICE, AN ILLINOIS CORPORATION, FOR PARAMEDIC AMBULANCE SERVICES", (the "Agreement"), a copy of which is attached hereto and made an express part hereof as if fully set forth herein; and

**WHEREAS**, the Corporate Authorities of the Village deem it advisable and in the best interests of the residents of the Village to approve the Agreement, to authorize and direct the Village President to execute the Agreement, to authorize and direct the Village Clerk to attest the Agreement and affix the Village Seal, and to authorize and direct the Village President and the Village Clerk to do all things necessary to put in full force and effect all the provisions set forth in the Agreement.

**NOW THEREFORE, BE IT RESOLVED** by the President and Board of Trustees of the Village of Burnham, Cook County, Illinois, in the exercise of its home rule powers, as follows:

**Section 1.** The Corporate Authorities of the Village of Burnham, Cook County, Illinois, hereby find that all of the recitals contained in the preambles of this Resolution are true, correct and complete and do incorporate them into this Resolution by this reference.

**Section 2.** The Corporate Authorities of the Village of Burnham, Cook County, Illinois, do hereby approve the written agreement entitled "AGREEMENT BETWEEN THE VILLAGE OF BURNHAM, COOK COUNTY, ILLINOIS, AN ILLINOIS MUNICIPAL CORPORATION, AND DALEY'S MEDICAL TRANSPORTATION, INC., d/b/a BUD'S AMBULANCE SERVICE, AN ILLINOIS CORPORATION, FOR PARAMEDIC AMBULANCE SERVICES", (the "Agreement"), a copy of which is attached hereto and made an express part hereof as if fully set forth herein.

**Section 3.** The Village President is hereby authorized and directed to execute the Agreement and the Village Clerk is authorized and directed to attest the Agreement and to affix the Village Seal.

**Section 4.** The Village President and the Village Clerk are hereby directed and authorized to do all things necessary to put in full force and effect all the provisions set forth in the Agreement.

**Section 5.** That this Resolution shall be in full force and effect from and after its passage and approval as provided by law.

**Section 6.** This Resolution and each of its terms shall be the effective legislative act of a home rule municipality without regard to whether such Resolution should (a) contain terms contrary to the provisions of current or subsequent non-preemptive state law, or, (b) legislate in a manner or regarding a manner not delegated to municipalities by state law. It is the intent of the Corporate Authorities of the Village of Burnham, Cook County, Illinois that to the extent that the terms of this Resolution should be inconsistent with any non-preemptive state law, that this Resolution should supersede state law in that regard within its jurisdiction.

**Section 7.** If any section, paragraph, clause or provision of this Resolution shall be held invalid, the invalidity thereof shall not affect any other provision of this Resolution.


**Section 8.** All ordinances, resolutions, motions or orders in conflict with this Resolution are hereby repealed to the extent of such conflict.

**Section 9.** This Resolution shall be published in pamphlet form by the authority of the Village President (Mayor) and Board of Trustees of the Village of Burnham, Cook County, Illinois.
