 - O A DECREASE IN YOUR WATER PRESSURE IS NORMAL WHILE THE HYDRANTS ARE BEING FLUSHED. THIS IS JUST A TEMPORARY INCONVENIENCE AND THE WATER PRESSURE WILL BE BACK TO NORMAL.
