1. Discussion of, consideration of, and taking action (approve or not approve) on the new Liquor application by Tiger Liquors Inc., a liquor store. The location would be 13755 S. Burnham Ave, Unit F, Burnham, IL 60633.

PUBLIC UTILITIES:

1. Discussion of, consideration of, and taking action to (approve or not approve) on authorizing Calumet City Plumbing to provide labor, material, & equipment in order to install a 12" EZ Valve at the above address between the Chicago Meter Vault and the Burnham Pump House. The plumbing contractor (PC) to excavate in North parkway of the alleyway North of 138th Place in order to expose the 12" water main. Set the required trench shoring. Clean and prep the water main. Install (1) 12" EZ Valve. Check for leaks. Verify the operation of valve. Install valve box, adjusted to match finished grade. Backfill with existing spoils and stone, compacting in lifts to grade. Maintenance of excavation and final restoration of same to be done by owner. Installation is scheduled for the Spring of 2023

NOTE: Main to be located by others prior to start of work.

Material / Spoils Removal / Stone: \$11,900.00

Labor: \$4,100.00 Equipment: \$1,600.00 **Total Cost: \$17,600.00**

2. Discussion of, consideration of, and taking action to (approve or not approve) on authorizing Calumet City Plumbing to provide labor, material, & equipment in order to remove and replace 2-6" Water Meters in main City of Chicago Feed Vault located near13730 S Brainard Ave. Plumbing Contractor (PC) to provide 2 - Sensus T-2 flanged meters, ScataMetrics duplexer and transmitters. Meters to be delivered to the City of Chicago Water Management office for bench testing prior to installation. Once tested and approved, Village of Burnham to shut water off to the vault from the City of Chicago feed, and the water main exiting the vault feeding the Village of Burnham. The existing butterfly valves inside the vault do not have operating handles. The valves may not hold during the meter exchange and will not be operated. PC to cut out old bolts, remove existing meters and strainers and replace with new. Drill existing vault cover to mount transmitters. Install (1) Badger Beacon transmitter for the City of Chicago and (1) Sensus MXU for the Village of Burnham. Duplexer to be mounted inside the vault attached to concrete as high as possible. And to replace all piping and valves at the time of meter exchange: The Piping and valves in the vault are in bad shape. The Butterfly valve handles have rotted off and do not operate. The 10" x 6" flanged bull tees are to remain in place. Plumbing Contractor (PC) to remove and replace all associated 6" piping, valves and replace meters. Replace with new flanged gate valves, flanged spool, provide new pipe stands and install the new water meters.
