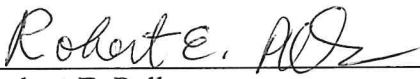
**CERTIFICATE OF COMPLIANCE WITH TRUTH IN TAXATION LAW**

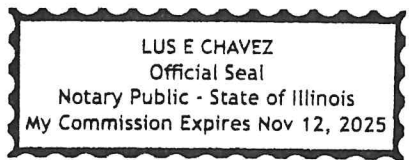

3. That this Certificate is made in compliance with Section 18-90 of the Truth in Taxation Law, 35 ILCS 200/18-90.

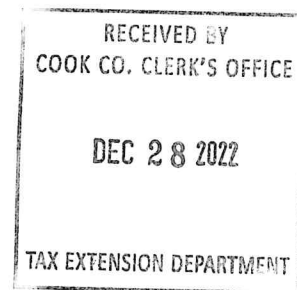

BEGINNING MAY 1, 2022 AND ENDING APRIL 30, 2023  
OF THE VILLAGE OF BURNHAM, COOK COUNTY, ILLINOIS

BE IT ORDAINED by the President and Board of Trustees of the Village of Burnham, Cook County, Illinois in the exercise of its HOME RULE POWER, as follows to wit:

**Section 1.** A tax for the following sums of money, or as much thereof as may be authorized by Law, to defray all expenses and liabilities of the Village of Burnham for all corporate purposes, as Appropriated for the current fiscal year commencing May 1, 2022 and ending the 30<sup>th</sup> day of April 2023, by annual appropriation ordinance of the Village of Burnham for the fiscal year beginning May 1, 2022 and ending the 30<sup>th</sup> day of April 2023, passed by the Board of Trustees of the Village of Burnham at a legally convened meeting was held July 26, 2022 and approved by the Village President of the Village Of Burnham on July 26, 2022 be and the same hereby levied upon all taxable property subject to taxation within the Village of Burnham as the property is assessed and equalized for State and County purposes for the fiscal year commencing the 1<sup>st</sup> day of May, 2022 and ending on the 30<sup>th</sup> day of April 2023, for all purposed as specified as follows:

<p><b>Section 2.</b> That the total amount of Four Million Two Hundred Eighteen Thousand Dollars and 00/100 cents (\$4,218,000.00) ascertained be, and the same is hereby levied and assessed on all property subject to taxation within the Village of Burnham, according to the value of said property as the same is assessed and equalized for State and County purposes for the current year.</p>

<p><b>Section 4.</b> That the Village Clerk of the Village of Burnham be and she is hereby directed forthwith to file a certified copy of this Ordinance with the County Clerk of Cook County for the purpose of having extended the taxes levied under the terms hereof, and to enable the proper authorities to collect the same when extended.</p>			

**Section 5.** This Ordinance shall be in full force and effect from and after its passage and approval according to law but, it shall subsequently be published in Pamphlet Form by the authority of the President and Board of Trustees of the Village of Burnham, Cook County, Illinois.

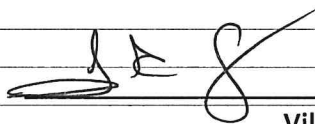
