### WHOLESALE UPDATE FOR 2022

As your Water Supplier, we are required to present monitoring data and other information about your water for your Consumer Confidence Report. Therefore, this information is as follows:

- Our source water is Lake Michigan, which is surface water, located in Hammond, Indiana.
- The following contaminants were **Below Detection Level (BDL)** in the Finished Water at the entry point to our distribution system.
  - a. Synthetic Organic Contaminants (SOC's)  
–Atrazine-BDL–below detection level of **0.1** ppm
  - b. Volatile Organic Compounds (VOC's)
  - c. Any Unregulated Contaminants
- Inorganic Compounds (IOC's) were detected as follows:
  - a. Fluoride ranged from **0.05** to **1.0** mg/L
  - b. Sodium **0.11** mg/L
  - c. Barium **0.021** mg/L
  - d. Nitrogen, Nitrate-Nitrite as (N) **0.3842** mg/L
- Turbidity Levels at the entry point to the Distribution System were as follows:
  - a. **0.03 – 0.21** NTU's – Tap
  - b. 100% of our samples were equal to or less than 0.30 NTU's
- Disinfectant and Disinfection By-Products
  - a. Disinfectant Residual: **1.6 – 2.2** mg/L
  - b. Total Haloacetic Acids: **2.4 – 5.3** mg/L

## City of Chicago, Dept. of Water Management Source Water Assessment Summary For the 2021 Consumer Confidence Report (CCR)

### Source Water Location

The City of Chicago utilizes Lake Michigan as its source water via two water treatment plants. The Jardine Water Purification Plant serves the northern areas of the City and suburbs, while the Sawyer Water Purification Plant serves the southern areas of the City and suburbs. Lake Michigan is the only Great Lake that is entirely contained within the United States. It borders Illinois, Indiana, Michigan, and Wisconsin, and is the second largest Great Lake by volume with 1,180 cubic miles of water and third largest by area.

### Susceptibility to Contamination

The Illinois EPA considers all surface water sources of community water supply to be susceptible to potential pollution problems. The very nature of surface water allows contaminants to migrate into the intake with no protection only dilution. This is the reason for mandatory treatment of all surface water supplies in Illinois. Chicago's offshore intakes are located at a distance that shoreline impacts are not usually considered a factor on water quality. At certain times of the year, however, the potential for contamination exists due to wet-weather flows and river reversals. In addition, the placement of the crib structures may serve to attract waterfowl, gulls and terns that frequent the Great Lakes area, thereby concentrating fecal deposits at the intake and thus compromising the source water quality. Conversely, the shore intakes are highly susceptible to storm water runoff, marinas and shoreline point sources due to the influx of groundwater to the lake.

### 2022 Voluntary Monitoring

The City of Chicago has continued monitoring for Cryptosporidium, Giardia and E. coli in its source water as part of its water quality program. No Cryptosporidium or Giardia was detected in source water samples collected in 2022. Treatment processes have been optimized to provide effective barriers for removal of Cryptosporidium oocysts and Giardia cysts in the source water, effectively removing these organisms in the treatment process. By maintaining low turbidity through the removal of particles from the water, the possibility of Cryptosporidium and Giardia organisms getting into the drinking water system is greatly reduced.

In 2022, CDWM has also continued monitoring for hexavalent chromium, also known as chromium-6. USEP A has not yet established a standard for chromium-6, a contaminant of concern which has both natural and industrial sources. **Sources of Drinking Water.** The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pickup substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife. Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban storm water runoff, industrial, or domestic wastewater discharges, oil and gas production, mining, or farming. Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses. Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff, and septic systems. Radioactive contaminants, which can be naturally-occurring or be the result of oil and gas production and mining activities.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water which must provide the same protection for public health. Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. If present, elevated levels of lead can cause serious health problems; especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. We cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential

for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Primary sources of pollution in Illinois lakes can include agricultural runoff, land disposal (septic systems) and shoreline erosion.

MCLGs allow for a margin of safety.</p> <p><b>Maximum Contaminant Level (MCL):</b> The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.</p> <p><b>Maximum Residual Disinfectant Level (MRDLG):</b> The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.</p> <p><b>Maximum Residual Disinfectant Level (MRDL):</b> The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.</p> <p><b>Range of Detection:</b> This column represents a range of individuals sample results, from lowest to highest that were collected during the CCR calendar year.</p> <p><b>Date of Sample:</b> If a date appears in this column, the Illinois EPA requires monitoring for this contaminant less than once per year because the concentrations do not frequently change. If no date appears in the column, monitoring for this contaminant was conducted during the Consumer Confidence Report calendar year.</p> <p><b>Action Level (AL):</b> The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.</p> <p><b>Avg:</b> Regulatory compliance with some MCLs are based on running annual average of monthly samples.</p> <p><b>Treatment Technique (TT):</b> A required process intended to reduce the level of a contaminant in drinking water.</p> <p><b>ND:</b> Contaminant not detected at or above the reporting or testing limit.</p> <p><b>N/A:</b> Not applicable</p> <p><b>Highest Level Detected:</b> This column represents the highest single sample reading of a contaminant of all the samples collected in 2021.</p> <p><b>ppb:</b> micrograms per liter or parts per billion - or one ounce in 7,350,000 gallons of water.</p> <p><b>ppm:</b> Milligrams per liter or parts per million - or one ounce in 7,350 gallons of water.</p> <p><b>Turbidity</b> – Turbidity is a measure of the cloudiness of the water. We monitor it because it is a good indicator of water quality and the effectiveness of our filtration system and disinfectants.</p> <p><b>Unregulated Contaminants</b> – A maximum contaminant level (MCL) for the contaminant has not been established by either state or federal regulations, nor has mandatory health effects language. The purpose for monitoring this contaminant is to assist USEPA in determining the occurrence of unregulated contaminants in drinking water, and whether future regulation is warranted.</p> <p><b>Fluoride</b> – Fluoride is added to the water supply to help promote strong teeth. The Illinois Department of Public Health recommended an optional fluoride level of 0.7 mg/L with a range of 0.6 mg/L to 0.8 mg/L.</p> <p><b>Sodium</b> – There is no state or federal MCL for sodium. Monitoring is required to provide information to consumers and health officials who have concerns about sodium intake due to dietary precautions. If you are on a sodium-restricted diet, you should consult a physician about the level of sodium in the water.</p> <p><b>Level 1 Assessment</b> – A level 1 assessment is a study of the water system to identify potential problems and determine (if possible) why total coliform bacteria have been found in our water system.</p> <p><b>Level 2 Assessment</b> – A level 2 assessment is a very detailed study of the water system to identify potential problems and determine (if possible) why an E. coli MCL violation has occurred and/or why total coliform bacteria have been found in our water system on multiple occasions.</p>
